# NSRA Agreed Value Insurance Scheme

## Valuation Guidelines

Dear Member

Listed below are some guidelines on how to present your application for an Agreed Valuation under the terms of the NSRA Insurance Scheme. Please note that I represent the NSRA and as such am not associated with any insurance company; that is handled by ClassicLine Insurance, to whom all enquiries should be directed.

This scheme is for pre-1973 vehicles only - specifically Street Rods, Customs and Modified American vehicles.

### Your application must include all of the following:

#### 1. Personal Details

Your full name, address, telephone number (in case of queries) and, most importantly, a copy of your current NSRA membership card clearly showing your valid membership number (this scheme is specifically for NSRA members only). In addition to this we also require your NSRA Scheme policy number and/or renewal date.

#### 2. Vehicle Description

A full description of the vehicle covering all major components i.e. body, chassis, engine, transmission, axles. Please use the form on the reverse of this document or attach a comprehensive description.

#### 3. Vehicle Images

Please supply a minimum of four images showing front, rear, interior, engine and both sides of the vehicle. The best format for these would be:

- One corner shot showing one side with either the front or the back
- One corner shot with the other side and the remaining end
- A shot of the vehicle's interior
- A shot of the engine

If there are any other features or even build-up shots that you feel would be helpful in arriving at a valuation, please enclose them. Only one full view shot is kept for club records - all others will be returned to you or forwarded onto ClassicLine Insurance. Please make sure that all images are clear, well lit and that there are no obstructions obscuring the view of the vehicle. Date-stamped images are a definite plus (especially for re-valuations). Printed photos must be on glossy paper and no larger than 6" x 4" size or equivalent. If emailing photos, please make them low resolution to reduce the file sizes.

#### 4. A stamped, self addressed envelope (ideally C5 size)

This is so that a copy of the valuation, any images and documents can be returned to you. If you would like the valuation, along with any images and documents, to be forwarded directly to ClassicLine Insurance, please enclose an extra stamped addressed envelope.

#### 5. Applications for Renewal of Valuations

If you are applying for a re-valuation, the above requirements still apply along with the addition of a copy of the last valuation. If this is not available, please include details of the date of the last valuation and any modifications which have been performed on the vehicle since this date.

**It is important to bear in mind that this valuation is only for use in conjunction with the NSRA Insurance Scheme, placed with Chaucer Insurance at Lloyds and administered by ClassicLine Insurance. This valuation is only valid for two years and must be renewed prior to its expiry.**
